### **VORTEX News**

Did you know that VORTEX is structured around three research areas? While all our doctoral candidates are conducting research on radicalisation, three thematic subgroups were formed to promote an intensive and future-oriented exchange on similar topics. One group of doctoral candidates and their supervisors focuses on the internal dynamics of radical groups and individuals, and another on the social context of these radicalisation processes. The third research area deals with access points for measures of preventing and countering violent extremism. Our research areas serve not only as dialogical forums but also as analytically significant tools to ensure that the doctoral projects are conceptually and empirically relevant and feasible. They achieve this by enabling cross-referencing, adding comparative dimensions, and fostering empirical synergies. In the following, we briefly introduce the scope of the different research areas.

#### Pathways of Radicalisation

Radicalisation is a complex, interactive process that occurs on both cognitive and behavioural levels, often supported by online and offline communities. It typically affects individuals or groups with a strong need for significance and involves co-escalation dynamics among radicalised groups and intervention efforts. Right-wing extremists and Islamist groups frequently exploit societal fears to fuel radicalisation. External influences, including the American alt-right, Russia, and ISIS, further impact radicalisation in Europe, particularly in socially disadvantaged or weakly governed areas. Radicalisation manifests in both religious and secular forms across national, transnational, and international levels.

### Social and Political Contexts of Radicalisation

Equally relevant is the political, legal, and social response to these developments. Antiterrorism policies have sometimes resulted in harsh laws that compromise human rights (particularly, but not exclusively, outside Europe) and grant intelligence agencies extensive surveillance powers. Concurrently, counterterrorism efforts have spurred a range of innovative preventive measures led by civil society organisations, state entities, or both. Balancing effective countermeasures with respect for human rights and the rule of law is delicate, as these interwoven processes risk undermining essential normative achievements and agreements upheld by the EU, the international community, and global society. Understanding and explaining these dynamics is crucial and calls for multidisciplinary research and collaboration between fundamental research and practice.

#### **Countering Radicalisation**

Over the years, numerous research centres, governmental bodies, academic journals, and departments focused on terrorism and radicalisation have emerged. Following 9/11, attention to radicalisation has surged, yet much research and public debate still regard radicalisation as a unidirectional process that inevitably leads to violence. Current research is divided between security-focused approaches, which seek immediate, often punitive, solutions, and socio-cultural perspectives that view radicalisation as rooted in complex social, economic, and cultural factors requiring long-term intervention. Building on the work of the doctoral students, this research area has delved deeper into the concept of terrorism and prevention, its evaluation structures, as well as implementation practices. Over time, gaining access to the field site has also become a significant topic of discussion, as it is particularly sensitive in radicalisation research.

## News from VORTEX doctoral candidates



Lotta Rahlf spent six weeks at the Centre for Research on Extremism (C-REX) at the University of Oslo to exchange ideas about learning and evaluation in the field of preventing and countering violent extremism (PCVE). She also took the opportunity to conduct several interviews with politicians, practitioners, and researchers on how learning takes place in the Norwegian PCVE field and how institutionalised evaluation is. Indeed, various Norwegian stakeholders were very open to these topics and keen to explain the knowledge-based approach that underpins their multiagency work.



Laura Stritzke just completed her secondment at Université Libre de Bruxelles (ULB) where her co-supervisor Corinne Torrekens and colleague Marzena Oliveira Ribas are based. She had the opportunity to present her conceptual framework and methodological approach to the "Group for research on Ethnic Relations, Migration & Equality" (<u>GERME</u>) which has provided her with different perspectives on the relevance of her research beyond the scope of extremism prevention. Further conversations with colleagues have also yielded valuable insights into the practices of prevention in Belgium.


