VORTEX News

VORTEX Virtual Training Event (October 6-8, 2025)

From October 6 to 8, 2025, the VORTEX Virtual Training Event, organised by the University of Oslo, successfully took place. The VORTEX network attended keynotes and engaged in discussions focusing on the dissemination of scientific knowledge and the impact of our research on policy and practice. Kristian Steiner provided detailed guidance on how to decide for the right publication outlet, what pitfalls to avoid, and how to strategise academic publishing. Furthermore, Tore Bjørgo talked about how to disseminate research findings effectively to policymakers and practitioners. The network also hosted external guest Eviane Leidig, who shared her experience in disseminating her research in various ways, including online. The event concluded with dedicated supervision team meetings with the doctoral candidates.
















News from VORTEX doctoral candidates



Laura Stritzke

In September, Laura held a presentation at the 7th Nordic Conference on Violent Extremism at Aarhus University in Denmark, where she about Practitioner Perspectives Across Institutional Contexts on Navigating Support and Control in Extremism Prevention. Furthermore, Laura took part in the EU Knowledge Hub Policy & Practice Joint Event on Minors in October. This opportunity offered not only valuable insights into ongoing efforts across Europe, but also a great chance to connect with experts, practitioners, and policymakers working on the prevention of radicalisation among young people. Throughout the keynotes, panels, and breakout groups, she gained a deeper understanding of the diverse approaches and challenges in different countries—especially when it comes to prevention work in schools and building resilience among minors.



Rohan Kit Baines Stevenson

In October, Rohan completed the Europaeum Scholars Programme, which brings together doctoral researchers from leading European Universities for advanced training in policy, leadership and interdisciplinary collaboration. As part of the programme, a policy proposal had to be designed in a small group. The programme culminated in a policy conference in Brussels, where his group presented the policy proposal for which they have been working on for the past 15 months to European policymakers. The proposal is entitled 'The European Model: Guaranteeing the Human Rights of Sex Workers in the EU'.



Violette Mens

Since the previous newsletter, Violette has had the chance to conduct a workshop with here two colleagues Camilla Winde-Gissel and Heidi Campana-Piva at the STS-CH conference in Zurich from the 10th to the 12th of September 2025. There, she explored the challenges of radicalization in light of AI and more specifically political deep-fakes with a varied and interesting crowd. She later got to attend the Nordic Conference on Violent Extremism in Aarhus from the 25th to the 26th of September. There, she met with her colleagues Camilla Winde-Gissel, Laura Strizke and Lotta Rahlf and presented a joint article draft on trust in the PCVE sphere. Finally, Violette attended the Aleksanteri Conference in Helsinki from the 22nd to the 24th of October, to present her PHD work. More linked to her PHD work, Violette hopes her first article will soon be sent out to be published and has finished her data retrieval and interview phase. She is now coding and analyzing and hopes to start writing her thesis by the end of March 2026

Lotta Rahlf

Lotta has presented her work entitled 'The institutionalisation of evaluation and quality management in preventing and countering violent extremism - comparative perspectives' at the 7th Nordic Conference on violent extremism at Aarhus University. She also gave a presentation with the title 'Institutionalisierung von Evaluation und Qualitätsmanagement in der Extremismusprävention'. at the Annual Conference on the German Evaluation Society at Saarland University Saarbrücken in Germany. Furthermore, as a mentee in the EU Knowledge Hub Mentoring Programme Lotta joined a training in Brussels from 9.-10.10 which was designed to bring the diverse cohort of mentees to a common level of knowledge about P/CVE and facilitate exchange among them. The Mentorship Programme runs for two years and includes personal support for mentees from experienced P/CVE practitioners or scholars.
